On 03/05/2017 at 4:05pm, I Deputy Irby was on patrol approximately 17 miles West of Sterling City, Texas in 158 when I observed a Maroon Dodge pickup approaching me from the rear traveling at a high rate of speed. I then checked the speed of the vehicle using my stalker radar in rear radar same direction mode and it was determined that the vehicle was traveling 90mph in a 75mph zone. The vehicle then passed and I then engaged my emergency lights to perform a traffic stop. When the vehicle started to pull over, I could see the driver reach for his visor and grab at something. He then dropped what he had grabbed and he began to move quickly trying to find it. The driver then opened the middle console area and then closed it. The driver then pulled the vehicle over and stopped. When contacting the driver, I then asked for his driver's license and insurance. The driver was identified as Israel Garcia Sanchez DOB 12/08/1974. I then asked the driver to roll the back window down so I could make sure there was nobody in the back seat. After he rolled the window down I observed a bottle of Remy Martin Champagne Cognac sitting in the back-seat area with the seal broken and the bottle was 1/2 full. I then asked the driver if he had been drinking and he stated no. The driver was then asked to exit the vehicle and walk to the rear so I could speak with him. When speaking with Sanchez I could smell an odor of alcohol emitting from his breath. Sanchez also had red bloodshot glazed eyes. I then asked Sanchez if there was any other opened alcoholic beverages in the vehicle. He then stated no. I then explained that I would search the vehicle for any more open containers due to the opened bottle on champagne that was in plain view in the back seat. While searching the vehicle, I started with the passenger side and asked the passenger to exit the vehicle and show his Identification. The passenger then identified himself as a Garcia, Isac DOB 11/13/2017. I then asked the Passenger if he had been drinking and he stated no. I then began searching the vehicle and under the passenger seat was a small clear bag with a white powdery substance inside. I later field tested the substance which came back positive for Cocaine. I then asked both Sanchez and Garcia what was inside the bag and whose it was. They both then stated they did not know and it wasn't theirs. I then moved to the console area and inside were 2 opened 12oz Michelob Ultra cans 1/4 full. I then moved a plastic bag that was located under the alcoholic beverages that was in the console and another small clear plastic bag with a white powdery substance fell out onto the passenger seat. The white powdery substance also field tested positive for cocaine. Both subjects stated that the powdery substance found was not theirs. I then placed both Sanchez and Garcia in double locked handcuffs and placed them in the back of my patrol unit. When searching the vehicle further, in the drivers seat area there was a white powder substance located in a crack on the seat. That substance was also field tested by Chief Deputy Shoemate and came back positive for Cocaine. Best Connection wrecker service out of Robert Lee, Tx was then contacted about the vehicle bearing Tx Lp CSY0498 and arrived shortly and took control. I then transported Sanchez and Garcia to the Sterling County Courthouse where they were processed and both charged for Possession Of Controlled Substance PG1<1G SJF. The two small plastic baggies containing a white powder substance weight less than One Gram. Border Patrol was also notified about Garcia due to him not having any identification. Border Patrol then placed an immagration hold on Garcia. I transported Sanchez and Garcia to the Tom Green County Jail in San Angelo, Tx.

03-06-2017 The 2 small clear bags with the white powdery substance was sent off for testing to DPS Abilene Crime Lab.






