(b) (7)(C), (b) on 07/18/2017:

On Tuesday, July 11, 2017 at approximately 12:19 p.m., DUSM (b) (7)(C), (b) (7)(F), received notification from Tom Green County Jail nurse, (b) (7)(C), (b) (6) , advising that USMS inmate, Isac GARCIA-WISLAR, was being transported to Shannon Medical Center for a possible kidney infection.

On July 12, 2017 at approximately 10:00 a.m. GARCIA-WISLAR was transferred to the intensive care unit (ICU) after a cardiac arrest. GARCIA-WISLAR never regained consciousness and was placed on life support. The medical staff indicated GARCIA-WISLAR had kidney failure, cirrhosis, a mass on his liver, sepsis and acute appendicitis.

On July 14, 2017 at approximately 2:53 p.m., physicians pronounced GARCIA-WISLAR dead. The Justice of the Peace (JP) and Texas Rangers were called to the hospital for a possible inquest. The JP officially pronounced GARCIA-WISLAR dead at approximately 3:35 p.m. and ordered an autopsy. The cause of death will be determined by the medical examiner. The Texas Rangers will be
