ACCORDING TO THE FEMALE, THE CALLER SAID HE MET ONE OF "OUR" PEOPLE AT A GUN SHOW AND WANTED TO KNOW IF HE COULD COME AND VISIT IN A WEEK OR SO. THE FEMALE SAID STRASSMEIR SAID HI DID NOT REMEMBER MEETING THIS PERSON. SHE DOES NOT KNOW IF STRASSMEIR RETURNED THE CALL.

IN A "DAILY OKLAHOMAN" NEWSPAPER ARTICLE DATED JANUARY 28, 1996, LYONS STATED THAT STRASSMEIR RECALLED MEETING A "SQUARED AWAY INDIVIDUAL" APPARENTLY JUST OUT OF THE ARMY AT A GUN SHOW IN TULSA APPROXIMATELY 18 MONTHS BEFORE THE BOMBING. ACCORDING TO LYONS, STRASSMEIR, OF HIS OWN RECOLLECTION, CANNOT RECALL MEETING MCVEIGH SPECIFICALLY, BUT, THAT IT PROBABLY WAS MCVEIGH.
